One person came to our office with one big suitcase containing some old papers. The meeting was scheduled with him regarding one old matter.

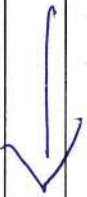

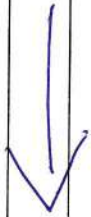
