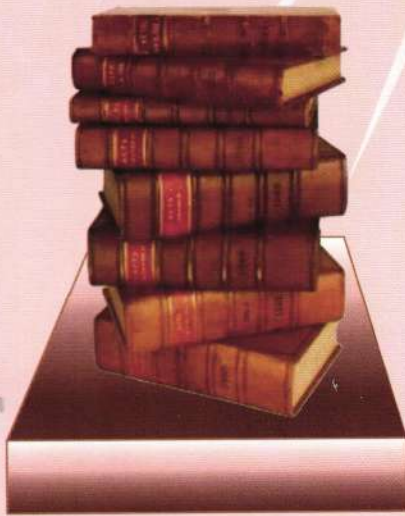
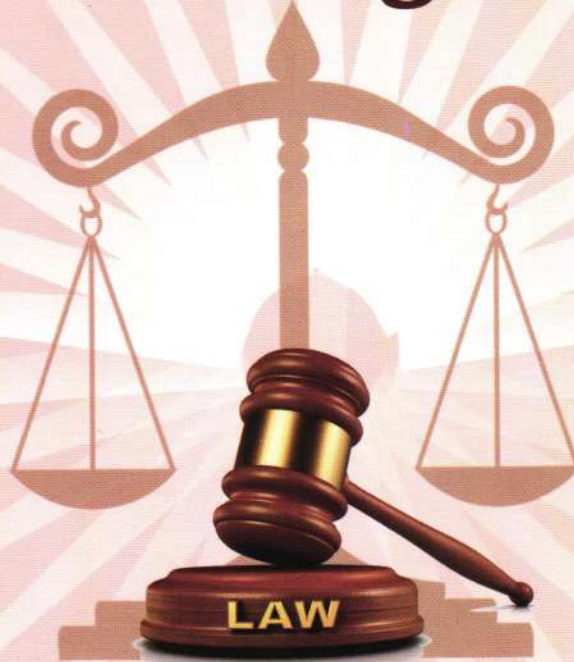

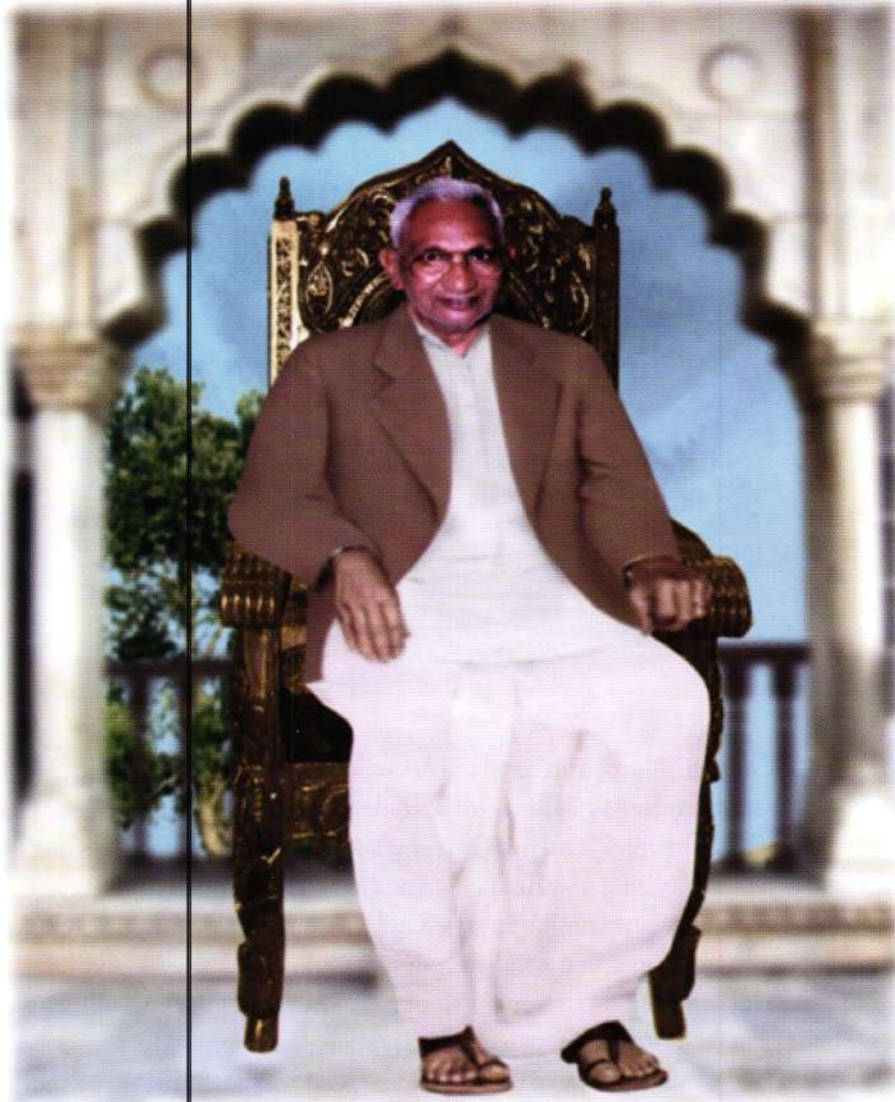

A transparent admission procedure is followed strictly based on standard norms. Any modification in admission guidelines will be notified on the college notice board at the time of admission. Neither the management nor the college accepts any donation or capitation fee for admission to any course offered by the college. The public is cautioned not to fall for any solicitations or offer of donations.

Admission Procedure

A) An applicant who has successfully completed Senior Secondary School course (+2) or equivalent (such as 11+1, A level in Senior Secondary School Leaving Certificate course) from a recognized University of India or outside or from Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course examination, with minimum of 45% marks in aggregate (candidate belonging to SC and ST Category with minimum 40% marks);

B) The applicant who has obtained +2 Higher Secondary Pass Certificate or First Degree Certificate after processing studies in distance or correspondence method is eligible for the course: Provided that, the applicant who has obtained 10+2 through open University system directly without having any basic qualification, are not eligible. Further provided that, applicants who are appearing/appeared for the qualifying examination (regular examination of that academic year) are also eligible to apply for the entrance examination. Such candidate will be eligible for admission only if they produce the Provisional/Degree certificate of the qualifying examination and the mark lists of all parts of qualifying examination at the time of admission.

C) And obtained score in CET conducted by the Competent Authority.

Documents to be attached along with "Application Form for Admission Process" :-

The candidates are required to carry All Original Certificates / Documents in support of their seat claim at the time of filling up Application Form for Admission.

- x) Other additional documents depending upon the category to which they have claimed the seat.

D) Age of Admission

As per notification by State CET Cell vide their letter no. CET-CELL/LLB-3/LLB-5-2016/AGE-RELAXATION/2016/5333 dated 17th October, 2016, Admission to the candidates who do not fulfill the age criteria prescribed by the Bar Council of India will be subject to outcome of Writ Petition no. 27289/2016 and other similar petitions pending in Hon'ble High Court.

E) GENERAL

Admission is purely on merit and is subject to availability of seats as per the directions issued by University of strictly based on the standard norms. Any modification in admission guidelines will be notified on the college notice board at the time of admission. The management or the college does not accept any donation or capitation fee for admission to any course offered by the college. The public is cautioned not to fall prey to any misleading information regarding admission in the college through donations.

F) ELIGIBILITY

Centralized Admission Process (CAP)

The Unaided Private Professional Educational Institution shall admit candidates through the Centralized Admission Process (CAP) as referred in sub-section (3) of section 3 of the Maharashtra Unaided Private Professional Educational Institutes (Regulation of Admission and Fees) Act, 2015. The stages of CAP shall be as stated below:

1. Display or publishing of Information Brochure by the Competent Authority.
2. Filling Online Application Form by Candidate for participation in the Centralized Admission Process.
3. Confirmation of Online Application Form and Document Verification at Facilitation Centre by the Candidate in person.
4. Display or Publishing of provisional merit lists, submission of grievances, if any, and display or publishing of Final Merit Lists.
5. Display of available Category wise Seats (Seat Matrix) for CAP Rounds I, II and III.
6. Filling up and confirmation of Online Option Form having preferences of Institutions before CAP Rounds I. Candidates may fill in choice of Institutes in decreasing order of their preference as specified by Competent Authority. The option form once confirmed shall be considered for allotment in CAP Rounds I, II and III.
7. Display of Provisional Allotment of CAP Rounds I, II and III indicating allotted institute.
8. Reporting and accepting offered seat will be as per the allotment of the CAP Round I, II and III, by the Candidate at Reporting Centre.
9. During the CAP, before accepting the allotted seat, a candidate can opt to Freeze or Float the choice of academic program for subsequent round(s), if any, of seat allocation as provided below:
 - a. Freeze: Candidates accept the offered seat and if they do not want to participate in any further rounds of seat allocation, such Candidates will not be considered in subsequent rounds of admission.
 - b. Float: Candidates accept the offered seat and indicate that, if admission to an academic programme in any institution of higher preference is offered, they will accept it. Else, they will continue with the currently accepted academic programme. Such Candidates will be considered in subsequent round of admission.
 - c. For candidates who choose the Float option and secure a seat of his/her choice of higher preference, then it would automatically result in the cancellation of the seat accepted by the candidates in the earlier round.
 - d. Floating options will not be available to a Candidate who is admitted to his First Choice.

Minority Students

The Minority seats shall be allotted to the candidates of the State belonging to the Minority Community to which the institution belongs by virtue of merit or in open category as per their inter- se-merit if the seat reserved for them are not available at their merit.[Government of Maharashtra Gazette No. MAHBIL/2009/37831 DATED 11th March,2016.]

Outside Maharashtra University Graduate/Post Graduates

Candidates from outside Maharashtra University will be considered as open category candidate irrespective of their caste/category and criteria applicable to open category candidates will be applicable to them.

Aggregate marks means the grand total of marks obtained by the candidate at the Certificate/Diploma/Degree in all semesters/ Years on which the Class/Grade is awarded by the Board/University.

In case the candidates are awarded Grade, /CGPA instead of marks, the conversion of Grades/ CGPA to percentage of marks would be based on the formula/procedure certified by the Board/University/Institution from where the candidate has obtained the Bachelor's Degree. The candidates will have to bring the necessary proof to that effect from the Board/University/Institution.

If the Grades of all Semesters/Years are taken into consideration for awarding Grade in Certification/Diploma/Degree, the same is to be considered and noted by the candidate while filling the form. It will be obligatory on the part of candidate to bring grade to percentage certificate from Board/University/Institution.

The percentage of Marks shall be calculated by rounding off to two place after decimal.

The candidate belonging to SC/ST,DT/VJ,NT(A),NT(B),NT(C),NT(D), OBC and SBC categories having caste certification from the State of Maharashtra only should produce "**Caste Certificate**" issued by the component Authority and candidates belonging to ST category should submit "**Tribe validity Certificate**" issued by the Scrutiny Committee of Tribal Department along with caste certificate. Candidate belonging to DT,VJ, NT(A),NT(B),NT(C),NT(D),OBC and SBC should submit '**Non Creamy Certificate**' as applicable at the time of verification of Documents/Admission, without which the candidates will not be eligible for CET Examination Fees Concession and admission on the reserved seat in the CAP process. Candidates belonging to other than Maharashtra State Universities will be treated as Open Category Candidate.

Prohibition to Register for Two Regular Courses of Study

No student shall be allowed to simultaneously register for a Law degree program with any other graduate or post-graduate or certificate course run by the same or any other University or an Institute for academic or professional learning; excepting in the integrated programme of the same institute.

Provided that, any short period, part time certificate course in language, computer science or computer application of an institute or any course run by centre for Distance Learning of a University, however, shall be accepted.
(Ref: (Rule6, Rules of Legal Education 2008, Bar Council of India)

All Admissions are subject to the approval of the University of Mumbai.

★ Conditions for Admissions to Second & Third Year LL.B. Course ★

For each subsequent year, students shall fill in a fresh admission form and pay the necessary fees on or before the date fixed.

Candidates for being eligible for admission to the Second Year of 3 years LL.B. course must have either passed in the examination of the First and Second semester or must have got exemption in at least six papers (excluding Practical Training Paper) of the first and second semesters.

Similarly, a candidate for being eligible for admission to third year of 3 years LL.B. course must have passed in all the papers of First and Second Semesters and must have either passed in the Third and Fourth Semesters or must have got exemption in at least six papers (excluding Practical Training Paper) of the Third and Fourth Semesters.

Enrolment

As per University Circular No. enroll/11930/2015 dated 12 May 2015, the students seeking admission for LL.B. First year should enroll themselves and pay necessary fees.

Scholarships / Free-ship / Concession including Backward Classes

Needy and deserving students and particular students belonging to SC/ST/OBC and EBC category are eligible to avail various Scholarships, Free-ships and other educational concessions.

Student, seeking admission on Reservation basis should apply online on <http://mahaeschol.maharashtra.gov.in> within 15 days from the date of admission.

Note: Students, who fail to submit the online form within the prescribed time should pay their Entire Fees within 8 days or else the Admission shall stand cancelled. For further Enquiry, students should contact college office.

The above fees structure is subject to revision by Government of Maharashtra Fees Regulatory Authority. Refund of Fees After Cancellation of Admission

- The Candidate shall apply online for cancellation and submit signed copy of system generated application for cancellation of admission to the institution.
- After receiving admission cancellation request from the Candidate, the institution shall cancel the admission immediately and generate online acknowledgement of cancellation of admission through institution login and issue a signed copy to the Candidate.
- The refund of fees before cut-off date of admission shall be made within two days i.e. total fees minus the processing charges of Rs.1000, or refund rule shall be as per the guidelines of the Competent Authority or the State Government, as the case may be.
- If the admission is cancelled after the cut-off date of admission declared by the Competent Authority, there shall be no refund except the Security Deposit and Caution Money Deposit.

NOTE : The students are advised to preserve their fees receipt carefully.

Refund of deposits/ admission cancellation fees will be made only by a cheque on submission of the original fees receipt. However, duplicate fee receipt may be issued on payment of Rs.50/- with the permission of the Principal.

Library Collection and Services

The library is the heart of the institution. It has a collection of books, periodicals and legal databases. Periodicals include National and International Law Reports. The library is well-furnished, centrally air-conditioned, Wi-fi enabled with a seating capacity of 100 students and stack of 13,000 books.

Reference books: includes Law Reports such as All India Reporter (1914 onwards), All England Law Reporter (1836 onwards), Canadian Bar Review, Halsbury's Law of England(4th Edition), Current Legal Problem, AIR Manual (4th, 5th, 6th editions), Warren's Forms and Precedents.

Subject reference books : Includes a comprehensive collection of books on Constitution, Jurisprudence, Indian Penal Code, Criminal Procedure Code, Civil Procedure Code, Indian Evidence Act, Contract, ADR, Company Law, International Law, Family Law, Human Rights etc.

Database Access

Library provide database access through Wi-fi within the premises and allows remote access for out of campus reference. Databases such as Heins Online, Manupatra, LexisNexis, West Law-India, SSC Online (Law), Proquest, India State, E-brary and 32 other databases are available for wide reference.

Tree Computers are particularly available for database reference as well as computer centre of 20 terminals is available for wide reference study.

Computer Lab

Keeping in mind the need for legal research, our institute has made available licensed databases to be used through exclusive IP Access. The Electronic Research Section is situated in the library and in the computer laboratory, which are equipped with computers that can be used by students representing college at various inter-collegiate competitions.

Reference and Study Room Section

Book in the Reference Section such as dictionaries, encyclopedias, reports, periodicals, university handbook, question papers etc. will be issued to a student against his identity card only for reference in the Library. Current periodicals as well as past numbers and bound volumes of periodicals will be available only for reference in the library.

Medical Facility on Campus

Sanskar Sarjan Education Trust is Associated with Mahaveer Clinic /dispensary which operates from 9:00am to 5:00pm. It's managed by fully qualified Medical Officers. Services of dispensary are available for attending all emergency aid and for OPD. This facility is available to all students and staff members of D.T.S.S institution.

Attendance

As per the University Ordinance 6086(Circular No. UG/01 of 2014 dated 5th May,2014):

- 1) There shall be the Attendance Committee, for smooth conduct of this ordinance , in every college/institute/Department of the University comprising of at least three members(to be nominated from other departments in case of the University Departments having less than 3 teachers), the Vice-Principal/ Senior Teacher (Convener) and at least two more teachers ensuring representation of the concerned faculties, nominated by the Principal/Director/Head.
- 2) Every bonafide learner shall ordinarily be allowed to keep terms for the given semester in a program of his enrolment, only if he fulfills at least seventy five percent(75%) of the attendance taken as an average of the total number of the lectures, practicals, tutorials etc. where in short and/or long excursions/field visit/study tour organized by the college and supervised by the teachers as envisaged in the syllabus shall be credited to his attendance for the total no of periods which are otherwise delivered on the material day/s. Further it is mandatory for every learner to have min 50% attendance for each course & average attendance has to be 75%.
- 3) The same ratio shall be applied for computing the attendance of the learners by creating the number of periods which are missed while participating in an extracurricular / co-curricular activity/ competition/camp/workshop/convention/symposium/seminar etc. where the said learner is officially representing the college / University / District / State / Country with permission of the Principal/Director/Head of the College/Institute/University Department or by the direction of the University Officer as the case may be where in for the purpose of computing the average attendance the periods missed for what is envisaged here in-above, at Sr. No. 2, shall be deemed to have attended by the said learner.

Without prejudice to what is stated here-in-above, the Principal / Director / Head of the concerned College/Institute/Department of the university shall be the competent authority to condone the absentee of any learner further up to additional 25%, if deemed fit and on recommendation of the attendance committee of the said college/Institute/Department of the university, wherein it is mandatory on the said committee to do natural justice by giving personal hearing to every learner falling short of minimum attendance for keeping terms and recommending case by case to the competent authority having verified the genuineness and gravity of the problem that justifies the learner to remain absent, which generally shall be limited to his own sickness , sickness of his parent, death of his parent etc. supported by valid evidence, documentary proof or otherwise.

Relevant Rule of the “Bar Council of India”

Save as provided in Section 24 (1) (iii) of the act, a degree in Law obtained from any University in the territory of India after the 12 March, 1967 shall not be recognized for purposes of Section 24(1)(iii) of the Act unless the following conditions are fulfilled. .

1. That at the time of joining the course of instruction in Law for a Degree in Law, he is graduate of a University, or possesses such academic qualification which are considered equivalent to a Graduate Degree of University by the Bar Council of India.
2. The Law degree has been obtained after undergoing a course of study in Law for a minimum period of Three years/ Five years provided in these Rules, and that the course of study in Law has been regular attendance at the requisite number of lectures, tutorials. Moot courts and practical training given by a college affiliated to a University recognize by the Bar Council of India.

Examination Pattern: Semester System

The LL.B. Degree will be conferred upon a candidate who has passed in, or cleared, all the papers prescribed for each Semester Examination in accordance with provisions relating to each Semester Examination . The performance of the students will be evaluated by the Examination to be conducted at the end of every semester and also by his/her performance in the Practical Training Papers as per the guidelines issued from time to time by the Bar Council of India.

Semester I to IV Examinations:

It was resolved that the recommendation made by the Board of Studies in Law and subsequent resolution passed by the Board of Examinations and Evaluation at its meeting held on 11 April , 2018 regarding the matter of conducting Semester I to IV of 3 years LL.B. examinations as per the question papers of the examinations sent by the Examination Section of the University and to declare the results of the same after assessing the answer scripts at respective College level from the First Half (Summer)2018 examinations to be held from April/May, 2018 be accepted.(University of Mumbai Circular No.-1844/2018).

Standard for Passing the LL.B Examination

To pass the examination the candidates must obtain 45% marks in each paper/s and Practical/s separately. Those candidates who obtain less than 60% of the same sitting will be placed in second class. Those of the successful candidates who obtain 60% marks and more than 60% marks in all paper/s in one and the same sitting will be placed in the first class. A candidates who obtain 45% marks in Theory paper/s and particular may, at his option be exempted from appearing in the paper/s and Practical/s as the case may be.If a candidate is allowed to join the next higher class as provided in the Ordinance relating to the different examinations, he will not be permitted to appear for the highest examinations unless (i) he has previously passed in the remaining subject/s of the lower examination, or (ii) he appears in that subject/s simultaneously with his appearance at the higher examination. In the latter case, however, he will under no circumstance be considered to have passed in the higher examination, or any part of it, unless he passes in the aforesaid subjects(with the percentage, if any required for the total)at the same time or within two years of his obtaining the marks necessary to pass the higher examination or any part of it in which separate passing or exemption as permitted by the Regulation.

Curriculum as Per University of Mumbai

Subjects for the LL.B. Degree Course [Three Years (Semester I to VI)] are as per University of Mumbai with effect from the Academic year 2004-05 for all the semesters.

Important : No candidates shall be allowed to appear for the First LL.B (Semester-II)/Second LL.B. (Semester-IV) and LL.B. Degree (Semester-VI) examinations unless he/she passes in Practical Training Paper.

Method of Teaching and Learning

Interactive teaching techniques are designed to aid comprehensive learning. Teaching methods include Class Room Lectures, Interactive Sessions & Discussions, Case Studies, Power Point Presentations, Documentaries, Seminars & Workshops ,Mooting (debating moot court point of law before a judge), Guest Lectures, Practical Training, Project Work , Field Visits etc.

Discussions, Case Studies, Power Point Presentations, Documentaries, Seminars & Workshops ,Mooting (debating moot court point of law before a judge), Guest Lectures, Practical Training, Project Work , Field Visits etc.

Discipline

Attendance is compulsory in lectures, seminars, moot courts and all college events. The attendance and the work of the students in the seminars, classes, moot courts etc. and also the progress at the college examinations and also their overall conduct will be taken into consideration while granting their terms and also their eligibility for the university examination.

Conduct of the students in the class as well as in the premises of the college shall be such as will cause no disturbance to fellow students or to other classes.

Students must not loiter about or congregate in the college premises while the classes are in progress. Students shall do nothing either inside or outside the college that will, in any way, interfere with its administration and smooth functioning of the institute.

Students must take proper care of the college property and help in keeping the premises neat and clean. Any damage done to the property and college will be compensated by the student.

In the premises of the college or in the name of the college, no Society, Association, Organization etc. shall be formed or collection be made, tickets be sold, function or meeting be held, person be invited to address students, social gathering be arranged or anything be printed or put on the notice board nor announcements be made without the permission of the Principal.

Students should, in their own interest, read notices or placed on the notice board, and website from time to time. If for any reason, the continuance of a student in the College is, in the opinion of the Principal, detrimental to the best interest of discipline of the college, he may direct such student to leave the college.

Students securing admission to the College are required to abide by all the Rules, Regulations and Instructions that may be issued by the College Authorities from time to time and submit to the normal enforcement of the same to the satisfaction of the college Authorities, whose decision in all matters shall be final and the same shall not be called in question on any ground whatsoever.

The permission may be granted, if an application is submitted by the students to the Principal through the members of the staff accompanying the students, at least one week prior to the scheduled date. The students will have to give an undertaking that they will behave properly and obey all instructions of the staff members' in charge, going at their cost and consequences. When an application for permission is submitted, it will be presumed that the students have taken prior permission from their parents/guardians to join the picnic or a tour. 6. National Service Scheme Committee (NSS)

26. Unfair Means Inquiry Committee

27. College Development Committee (CDC)

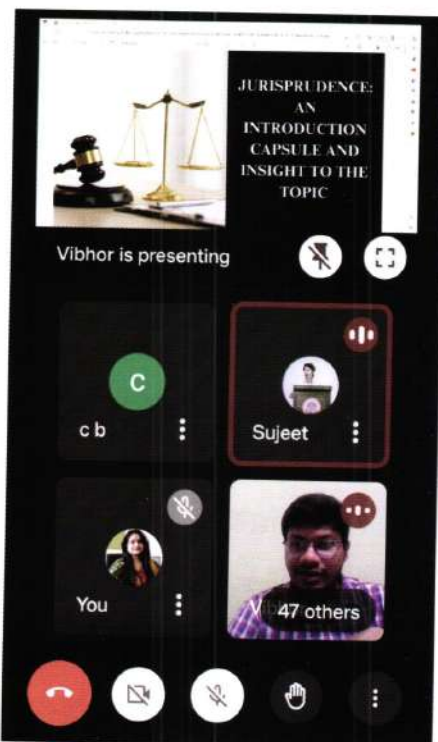
