College of Law (DTSS) and Hindi Vidya Prachar Samiti's College of Law, (here afterwards Hindi Vidya Prachar Samiti's College of Law (the parties) wish to initiate collaboration in the field of education through Hindi Vidya Prachar Samiti's College of Law academic programmes supported by University of Mumbai and approved by Bar Council of India and DTSS recognize their strengths in Education in Law Programme and their mutual interest in engaging themselves in academic operations.

Therefore D.T.S.S and Hindi Vidya Prachar Samiti's College of Law have reached the following Memorandum of Understanding :

<u>Objectives</u>

This Memorandum of Understanding (hereinafter referred to as the "MOU') intends to set out the general principles of mutual cooperation in the field of education, according to which the parties may jointly identify areas of mutual interest and carry out cooperative activities on the basis of reciprocity and mutual benefit.

Scope of Cooperation

The parties will encourage the following cooperative activities, in particular:

- a. Exchange of information on teaching, learning materials and literature relevant to Law education.
- b. Giving opportunities to attend seminars, workshops and short term programmes in the area of education, while extending invitations to each other's faculty to participate therein.
- c. Other areas as mutually agreed upon by the Parties.

Implementation and Funding

The cost of cooperative activities may be funded as mutually determined. All cooperative activities under this MOU will be subject to the availability of funds to the Parties.

Dispute Settlement

The Parties will consult together upon request of either side regarding any matter relating to the terms of this MOU and will endeavour jointly in a spirit of cooperation and mutual trust to resolve any difficulties or misunderstandings which may arise.

Amendment

This MOU may be amended by mutual written consent of the Parties.

Entry into Effect and Termination

This MOU will come into effect on the date of signature by the representatives of the two institutions. This MOU will remain in effect for an initial period of five (5) years w.e.f. 2020-21 to 2024-25 with an option to renew it for any extended period as it seems fit by the parties.
